TERMS & CONDITIONS OF CONTRACT-

1. The sealed tender in Single stage, two envelope method shall be submitted in accordance with underlying instructions and any tender not conforming to these shall be liable to be rejected. These instructions of tender shall form part of the contract on award of work.
2. The tenders shall be submitted in two sealed covers separately i.e. "Technical Bid" and "Financial Bid" super scribed with the name of work, due date of submission, in the following manner: -

- a) Technical Bid (First sealed Envelope):

First sealed cover super scribed as "Technical Bid for Printing work of 09th Convocation, 2023 Souvenir, RVSKVV, Gwalior containing the acceptance of Technical specifications of printing and documents as per check list enclosed herewith,

- b) Financial Bid (Second Sealed Envelope):

Second sealed cover super scribed as "Financial Bid for Printing of 09th Convocation, 2023 Souvenir, RVSKVV, Gwalior containing offered rates (in words & figures both) inclusive of all taxes with details and documents as per check list enclosed herewith.

3. **Qualifying Requirements**

The party should have successfully completed at least three technical reports/Souvenir/Compendium in Govt. department/University work of Extended Summary/ Annual Report Printing, costing not less than Rs. 1.00 lakh. The tender should also contain the following:

- a. Copy of Purchase or work order of Rs 1.0 lakh or above value,
- b. Details about the organization, GST/PAN and address proof.
- c. Number of years of experience in the similar field, similar means similar reports printing.
- d. Infrastructure and other printing facilities available with Tendered to ensure timely completion of the work.


The party should have requisite infrastructure available and shall employ suitable expert for the work on full time basis at Gwalior. If necessary, successful party have to ensure that suitable staff for this job shall also work on Saturdays / Sundays / Holidays as and when required by RVSKVV and all the charges are deemed to be included in the offered price.

4. The job of printing includes frequent proof-reading of Souvenir and other printing material. The printer would have to accept total responsibility for perfect execution of the job within the stipulated period.
5. The technical offer will be accompanied by Earnest Money Deposit of Rs. 5000/- (Rs. Five thousand only) by way of Demand Draft in favor of 09th Convocation 2023 payable at Gwalior.
6. The Earnest Money of Rs. 5000/- (Rs. Five thousand only) deposited by successful party will be converted as part of Security Deposit for performance of the contract after award of the tender. The earnest money will be refunded to all unsuccessful parties. The Earnest money will not carry any interest.
All tenders which are received without earnest money will be rejected.
7. Successful party will have to deposit additional amount of Rs. 5000/- (Rs. Five thousand only) totaling Rs. 10,000/- (Rs. Ten thousand only) (refer clause 5) towards security deposit which will not carry any interest.
8. Security Deposit of Rs. 10000/- (Rs. Ten thousand only) will be refunded to the successful Bidder after satisfactory completion of job.
9. The tender along with its supporting documents shall be in English and / or Hindi language only.
10. The tender shall remain valid for One Year from the date of approval of tender. It may be extended for three years with approval of competent authority on same rates..
 - a) Only technically qualified tenders will be eligible to be considered for Financial Bid opening.
 - b) Telegraphic or Tele fax tenders received or by hand will not be accepted. If delivered by Registered / Speed post, it should reach on or before the due date of opening of Bid, RVSKVV shall not be responsible for any loss or delay in transit.
 - c) Before submitting the tender, the party may visit the office of the Dean Faculty of Agriculture, RVSKVV, Gwalior Office so as to acquaint themselves with the nature of the work and other necessary information which may affect this offer.
 - d) Prices should be inclusive of all prevailing taxes and the same is required to be mentioned in percentage and value.
 - e) In the event of discrepancy in the rates written in words and the figures, the rates quoted in words will be considered final.

11. If the party fails to comply with the tender conditions, the work shall be done by RVSKVV at the risk and cost of successful Bidder and its responsibility will be fully with the Bidder. In such case, the expenses incurred will be deducted from the payment form successful Bidder.
12. Successful party shall has to submit 5 (Five) Cover design of Souvenir cum Extended Summary for approval in case of award of tender and proof of publication as required.
13. Successful party shall have to submit required draft copies of the printed document as per order to the RVSKVV, Gwalior, M.P. before starting the Print job. The printing will start only after obtaining written approval from this office.
14. **LIQUIDATED DAMAGES:** The time is the essence of this work, so as to complete in a specified period. The total time allowed for completion of work of issue of order from the date of award of contract. If the party fails to deliver any or all the printing material to the satisfaction of RVSKVV or fails to perform the services within the specified period in the contract, RVSKVV, Gwalior, M.P. shall, without prejudice to its other remedies available under the offer letter, deduct from the Contract Price, as liquidated damages, an amount at the rate of Rs.2500/- per day for the period of delay from the due delivery date to a maximum of 10percent. In addition to this, the University shall also have the right to get the work completed from other sources at the cost, risk and responsibility of the party if the ordered printed material are not printed and delivered to this office within the specified delivery schedule.
15. Successful party shall have to deliver all copies of ordered printed materials at Office of the Dean, Faculty of Agriculture, Rajmata Vijayaraje Scindia Krishi Vishwa Vidyalaya, Gwalior, M.P. and the prices shall be deemed to be included with the offer price.
16. **Payment terms:** Full & final payment shall be made within 30 days of satisfactory completion and delivery of work order printing of Souvenir and other printing material after mandatory deductions.
17. The Competent Authority reserves the right to reject all or any tender (s), wholly or partly, without assigning any reason whatsoever.
18. The party should have printing facility where the work is to be carried out.
19. The Tender offer should be submitted as per the checklist for both, Technical and Financial Bid.

20. The rates are to be quoted for 100 pages approximately for one souvenir and other printing material. For increased number of pages over and above 100 pages, rates per page are to be separately quoted in Price Bid and for pages increasing above 100 pages shall be additionally paid as per quoted rate.
21. All the pages of the Tender shall be signed and submitted with offer except the Financial Bid, which shall be separately submitted in second sealed envelope.
22. **EVALUATION CRITERIA:** Bidder quoting the lowest amount for total 300 copies of Souvenir and order of copies of printing material.
23. **ARBITRATION CLAUSE:**
All disputes, differences and questions arising out of or in any way relating to or concerning with this tender or subject matter thereof or the representative rights, duties or liabilities of the parties shall be referred to the sole arbitration of the arbitrator appointed by the Competent Authority of RVSKVV, Gwalior, M.P. or any person nominated by him. The arbitration shall be in accordance with the Arbitration and Conciliation Act, 1996 (or as amended from time to time). The arbitrator shall be entitled to extend the time of arbitration proceedings with consent of the parties. No part of the tender shall be suspended on the ground of pending arbitration proceedings. The Arbitration proceedings shall be held in Gwalior.

This tender shall be governed by and interpreted in accordance with the laws of India and subject to jurisdiction of Courts in Gwalior.
