**OTHER CONDITIONS FOR APPLICANTS FOR THE POST OF
Professor and Head of Departments/Associate Director Research/ Vishwa Vidyalaya Librarian**

- (a) The requirement regarding minimum percentage of marks shall be relaxed up to 5% in case of SC/ST/OBC candidates of M.P. and RVSKVV employees with a minimum of 5 (Five) years service in the Vishwa Vidyalaya at any one stage only (H.S.S.C. or Graduation or Post Graduation).
- (b) Maximum age limit is 50 years for the post of Professor and Head of Department/Associate Director Research/V.V. Librarian. No maximum age limit for RVSKVV/JNKVV employees. The Vice Chancellor can relax the age limit in special circumstances.
- (c) Reservation will be provided to SC/ST/OBC/EWS/ Persons with Disability (Divyang)/ Women candidates, domicile of M.P. shall be as per M.P. Govt. rules.
- (d) Knowledge of working in Hindi is essential.
- (e) The appointment to the post is temporary and candidates selected would be on probation as decided by the Vishwa Vidyalaya. Service conditions will be applicable as prevalent in Vishwa Vidyalaya and those framed by the Vishwa Vidyalaya from time to time. Further continuation of the services shall be subject to approval by the competent authority.
- (f) The services are terminable from either side by giving at least one month's advance notice in that regard or payment of three month salary in lieu of that after bond period.
- (g) Applicants must have the requisite qualifications and experience on the last date for receipt of applications. 
