1. Interested candidates will attend the Walk-In-Interviews with 2 copies of Application form along with self-attested copy of all the documents related to educational qualifications/experience/publications etc. The candidates must also bring all the original documents for verification.
2. These posts are purely temporary and purely on contractual basis subject to satisfactory performance. The selected candidates shall have no right / claim for regular appointment or absorption in university at any point of time.
3. The appointment may be continued till requirement of the University and the appointment may be terminated at any time.
4. Initially the appointment will be made for six months duration only and may be continued/ discontinued on the basis of performance of the candidate, However, maximum duration will not be extended beyond three years.
5. The authorities shall also reserve the right to terminate the contract of job as mentioned above, even before the completion of the contract period for which no appeal thereof shall be made.
