Rates of all items should be inclusive of supply of material labour charges, hire charges of tools & tackles, scaffolding, plant & machinery any applicable taxes and duties etc. In case of only labour involved items, supply of materials will not be included. Any defect found in the work carried out by the contractor will have to be rectified free-of-cost by the contractor.
- 15. Penalty as decided by the institute, will be imposed on the bidder:-
 - If there is any dereliction/irregularity in service or delay in service;
 - If the items supplied by the Bidder is substandard/non-quality or insuffifcient quantity;
 - If more than 50% of the total participants/staff/guests rate the services provided by the Tendere as either "average" or "poor".
